We, the undersigned, have read this release, the climbing/rappelling rules and understand all its terms. We execute it voluntarily and with full knowledge of its significance.

We further assert that we understand and agree to abide by all Park Regulations and those pertaining to the above described activities.

WARNING: BOLTS, PITONS OR OTHER EXISTING HARDWARE IS NOT APPROVED OR MAINTAINED BY THE TEXAS PARKS AND WILDLIFE DEPARTMENT. THE DEPARTMENT IS NOT RESPONSIBLE FOR ACCIDENTS AND VISITORS CLIMB AT THEIR OWN RISK.

CLIMBING /RAPPELLING RULES

1. "CLIMB CLEAN!" NO BOLTS, PITONS, OR OTHER EQUIPMENT MAY BE USED WHICH DAMAGES THE ROCK OR OTHER NATURAL FEATURES.
2. NO CLIMBING OR RAPPELLING PERMITTED IN CLOSED AREAS.
3. ALL PARTICIPANTS MUST SIGN LIABILITY RELEASE AT PARK HEADQUARTERS. (MUST BE 18 YEARS OLD OR HAVE WRITTEN PERMISSION OF PARENT OR LEGAL GUARDIAN.)
4. ALL RAPPELLERS MUST HAVE SOMEONE BELOW BELAYING.
5. THE STAFF RESERVES THE RIGHT TO EXAMINE ALL EQUIPMENT AND/OR PROHIBIT CLIMBING/RAPPELLING ACTIVITIES.

ALL STATE LAWS AND TEXAS PARKS AND WILDLIFE DEPARTMENT REGULATIONS APPLY.
